# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.mountainbrookfarm.org and Mountain Brook Farm and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Mountain Brook Farm include www.mountainbrookfarm.org. # **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, Mountain Brook Farm may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

Mountain Brook Farm may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. #### **Use of your Personal Information**

## **Sharing Information with Third Parties**

# **Tracking User Behavior**
